

# Privacy Policy of the SM16:7 online store.

## 1. General Information

This Privacy Policy describes how SM16:7, operated by Blazej Skrzypczak (an individual conducting sales under non-registered business activity in accordance with Polish law), collects, uses, and protects your personal data when you use our website sm167.com and make purchases through it.

By using this website, you agree to the terms of this Privacy Policy.

## 2. Data Controller

## 3. What Data We Collect

We collect only the data necessary to process your orders and provide customer service. This includes:

- Name and surname
- Shipping address
- Email address
- Phone number (optional)
- Payment information (processed securely by third-party providers such as PayPal or Stripe)
- IP address and basic browser data (collected automatically for security and analytics purposes)

## 4. How We Use Your Data

Your personal data is used for the following purposes:

- To process and ship your order
- To communicate with you about your purchase
- To handle returns, complaints, or warranty requests
- To meet legal obligations (tax, accounting, consumer protection)
- To improve our store and user experience

We do not use your data for automated decision-making or profiling.

## 5. Legal Basis for Processing

Your data is processed based on:

- Contract performance – when you make a purchase (Article 6(1)(b) GDPR)
- Legal obligation – e.g. accounting and consumer rights (Article 6(1)(c) GDPR)
- Legitimate interest – e.g. website security and customer communication (Article 6(1)(f) GDPR)

## 6. Data Storage and Security

We take appropriate technical and organizational measures to protect your data from loss, unauthorized access, or misuse. Your data is stored on secure servers provided by WIX.com and by verified third-party payment processors (See section 7.)

Data is kept only for as long as necessary to fulfill legal or contractual obligations (e.g. tax documentation or warranty claims).

## 7. Sharing of Personal Data

We only share your data with:

- Courier companies (for order delivery)
- Payment service providers:
  - PayPal
  - Stripe
- Website hosting provider:
  - wix.com

These entities process your data solely to the extent necessary to perform their services.

We never sell or trade personal data to third parties.

## 8. Cookies

Our website uses cookies to improve functionality and user experience.

Cookies are small text files stored on your device that help recognize returning users and save browsing preferences.

You can control or delete cookies in your browser settings. Disabling cookies may limit certain features of the website.

## 9. Your Rights (GDPR)

Under the General Data Protection Regulation (GDPR), you have the right to:

- Access your personal data
- Request correction or deletion
- Restrict or object to processing
- Request data portability
